

## NOTICE OF ANNUAL SCHOOL ELECTION

The trustee portion of the Circle High School and Elementary election has been cancelled. However Notice is hereby given by the undersigned Clerk of Circle High School District No. 1, McCone County, State of Montana that the Annual School Election will be held on Tuesday, **May 3, 2022**, at the following polling place(s):

**CIRCLE SENIOR CITIZENS CENTER 212 Main Str. Circle, MT; VIDA ELEMENTARY SCHOOLHOUSE, Shell Str. Vida, MT**

Electors will consider the following issue at the election:

HIGH SCHOOL: Shall the district be authorized to impose a building reserve levy in the amount of Twenty-Five Thousand Dollars (\$25,000) for 1 year and being approximately 3.42 mills, for a total amount of Twenty-Five Thousand DOLLARS (\$25,000) for the purpose of: future construction, equipping, or enlarging of school buildings or for the purpose of purchasing land needed for school purposes in the district to include surveys for the acquisition of prospective purchase of football field? Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$4.62 and on a home with a market value of \$200,000 by approximately \$9.23. Passage of this proposal will increase the taxes on agricultural land (Grazing Land and/or Tillable Land) with a market value of \$100,000 by approximately \$7.39 and on agricultural land (Grazing Land and/or Tillable Land) with a market value of \$200,000 by approximately \$14.77.

**The polls will be open between the hours of 12:00 noon and 8:00 pm on the day of the election.**

WHEREAS, the number of candidates filing a Declaration of Intent and Oath of Candidacy for the open trustee position on the Circle Public Schools Board of Trustees, District 1, McCone County, State of Montana, is equal to or less than the number of positions to be elected, the trustee election is not necessary. THEREFORE, the necessary 30 day notice is hereby given that the Circle Public Schools District 1, McCone County, State of Montana, trustee election is cancelled. (2 combined positions and the HS position from outlying school district 134)

A qualified registered elector who will be unable to go to the polls on the day of election may request an Application for Absentee Voter's Ballot from the school district clerk/election administrator's office located at: Circle High School District Office, 1105 F Ave, Circle, MT 59215

Absentee ballots will be counted by the judges at the polls on Election Day at the Senior Citizen Center, 212 Main Street, Circle, MT and the Vida Schoolhouse, Shell Street, Vida, MT and these absentee ballots will be counted using the following method: Hand Count by election judges after the polls close

If you miss this regular registration deadline (30 days prior to the election), you may still register at the county election office. The late registration certificate may be exchanged for a ballot at the school election administrator's office until the close of polls on Election Day. Late registration must be completed at the county election office located at: McCone County Courthouse, 1004 C Ave, Circle, MT

A late registrant may obtain a ballot on Election Day at the following location:  
Circle High School District Office, 1105 F Ave, Circle, MT
