

The Board of Trustees of Circle Elementary and High School District No. One, McCone County, met in special session on May 21, 2020 at 7:00 pm in the high school room 14. Trustees present: Bryce Hove, Tyrel Massar, Cary Phillips, Krista Beery, Tate Switzer (remotely). Absent: Dusty White. Also in attendance were Clerk Della Van Horn, Superintendent Preston Wenz, Principal Megan Murrell, & Amy McCloy.

Chairman Hove opened the meeting stating the purpose of the special meeting was 4 items: Prom discussion, Drivers Ed Class discussion, Summer part- time help recommendations & request for county to conduct district election for 20-21.

Plans are being made for prom to be held on June 13<sup>th</sup>. Under phase 2 COVID 19 guidelines from the governor, gatherings may be less than 50. 38 students have responded that they would attend. We would have bottled water, hand washing stations; grand march would be at the football field or possibly march down the sidewalk. We will be having a breathalyzer at the door before entering. If numbers are too high, it was suggested to limit it to Juniors and Seniors. Moved Phillips, seconded by Beery to deem the prom as an essential event gathering. Motion carried unanimously by the combined board.

Drivers Ed class is scheduled to begin July 7<sup>th</sup>. 23 students are signed up. Class will be held in the library where they can spread out. Moved by Massar, seconded by Phillips to deem Drivers Ed as an essential event. Motion carried unanimously by the combined board.

Mr. Wenz recommended the following for summer part time help at \$10.50 per hour: Averi Pasma, Jayme Bartelson and Rylan Hogan. Layne Richardson and Brian Kassner will be working on the football field and grounds. Averi, Jayme & Rylan would be 8 hours a day/3 days a week. Layne is 4 hours per day and Brian Kassner as needed. Moved by Phillips, seconded by Beery to hire the following for the summer of 2020: Averi Pasma, Jayme Bartelson, & Rylan Hogan at \$11.00 per hour for 8 hours a day/3 days a week (Rylan may be for just the month of June). Layne Richardson 4 hours a day at \$11.00 per hour, Brian Kassner at \$11.00 per hour on an as needed basis. Bill Johnson's part time contract will be increased to \$11.00 per hour beginning July 1. Motion carried unanimously by the combined board.

Discussion was held on requesting the county election administrator to conduct the school election in May 2021. By law, the request has to be made by June 1<sup>st</sup>. Moved by Phillips, seconded by Massar to pass a resolution to request that the county conduct the school election in May of 2021. Motion carried unanimously by the combined board.

Moved by Beery, seconded by Hove to adjourn the meeting at 8:00 pm. Motion carried unanimously by the combined board.
