

NOTICE OF ANNUAL SCHOOL ELECTION

Notice is hereby given by the undersigned Clerk of Circle High School District No. 1, McCone County, State of Montana that the Annual School Election will be held on Tuesday, **May 4, 2021**, at the following polling place(s):

BO – PEEP SCHOOLHOUSE, VIDA ELEMENTARY SCHOOLHOUSE

Electors will consider the following issues at the election:

Shall the Circle High School district be authorized to impose an increase in local taxes to support the general fund in the amount of \$3,492.44 which is approximately .46 mills for the purpose of proper maintenance and operation of schools? Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$.62 and on a home with a market value of \$200,000 by approximately \$1.24.

HIGH SCHOOL:

Shall the district be authorized to impose a building reserve levy in the amount of Fifty Thousand Dollars (\$50,000) per year for 3 years and being approximately 6.52 mills, for a total amount of \$150,000 Dollars for the purpose of raising money for the future construction, equipping, maintaining, or enlarging of school buildings? Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$8.80 and on a home with a market value of \$200,000 by approximately \$17.61.

ELEMENTARY:

Shall the district be authorized to impose a building reserve levy in the amount of Fifty Thousand Dollars (\$50,000) per year for 3 years and being approximately 10.00 Mills for a total amount of \$150,000 Dollars for the purpose of raising money for the future construction, equipping, maintaining, or enlarging of school buildings? Passage of this proposal will increase the taxes on a home with a market value of \$100,000 by approximately \$13.50 and on a home with a market value of \$200,000 by approximately \$27.00.

The polls will be open between the hours of 12:00 noon and 8:00 pm on the day of the election.

WHEREAS, the number of candidates filing a Declaration of Intent and Oath of Candidacy for the open trustee position on the Circle Public Schools Board of Trustees, District 1, McCone County, State of Montana, is equal to or less than the number of positions to be elected, the trustee election is not necessary. THEREFORE, the necessary 30 day notice is hereby given that the Circle Public Schools District 1, McCone County, State of Montana, trustee election is cancelled.

A qualified registered elector who will be unable to go to the polls on the day of election may request an Application for Absentee Voter's Ballot from the school district clerk/election administrator's office located at: Circle High School District Office, 1105 F Ave, Circle, MT 59215

Absentee ballots will be opened and counted by the judges at the polls on Election Day.

If you miss this regular registration deadline (30 days prior to the election), you may still register for the election by showing up at the county election office up to and including on election day. Between noon and the close of business on the day before Election Day, you may complete and submit a voter registration card. The county election office is located at: McCone County Courthouse
